NEW SHOPPING CENTER

You may have noticed that the new Crossroads IGA has been built next to Oaklawn on the corner of Shelbyville Road and South Beckley Station Road.

There is a sign on Beckley Station Road stating the store is now hiring. There are 8 gas pumps in front of the store. There is a Subway restaurant in the grocery store with a drive through window in the back. You can enter the center from Shelbyville Road using the same entrance for Oaklawn or you can enter from South Beckley Station Road. There is a possibility that the center will also have a bank and a restaurant.
